- e. In the event of the office bearers and executive committee members of the Author of the Trust cease to function as such for any reason whatsoever, the existing Board of Trustees will continue.
- f. The Board of Trustees many constitute various committees consisting of at least one member of the Board of Trustees and other members of the general body of the Author of the Trust to carry out specific activities as are entrusted to the committees by the Board of Trustees. Such committees shall function/carry out activities under the overall supervision and guidance of the Board of Trustees. 1. To delegate to any person or persons all or any of the foregoing powers, subject however, to their retaining control over the action and conduct of the person to whom the powers are delegated.

m. To open and operate or provide for operation of bank accounts to be opened in scheduled commercial banks and cooperative banks. The Board of Trustees shall pass specific resolutions for opening each account. The account shall be operated by any two of the trustees as are authorized by the Board of Trustees.

The Board of Trustees shall apply the income of the trust and its funds and properties solely for the objects of the trust and no part of its income/funds/property shall be utilized to pay dividend or profits to the trustees or to any other person.

9. BENEFITS:

The benefits of the trust shall be available to the general public irrespective of caste, creed or religion.

10. RIGHT OF THIRD PARTIES OR BENEFICIARIES/DONORS/ ENDOWERS:

The allotment, distribution, expenditure and application of funds, donations, gifts, contributions, subscriptions, endowments etc made for carrying out the purpose of the trust shall be at the absolute discretion of the trustees and it shall not be questioned by the donor, endower, subscriber, contributor or the beneficiaries or any other member or persons whosoever, in any manner whatsoever. The decisions taken by the Board of Trustees shall be absolute and Final.

11. **DISSOLUTION:**
